Prescribed Purposes - Fins réglementaires

The performance of a contract entered into by the Government of Canada, the government of a province, the government of a municipality acting on behalf of a police force, or a police force, or by a person acting on behalf of such a government or a police force.

The inspection, development or testing of a prohibited firearm, prohibited weapon, prohibited device or prohibited ammunition, or any component or part thereof, for or on behalf of a public officer, as defined in subsection 117.07(2) of the Criminal Code, who is acting in the course of his or her duties or employment.

Address: This licence is valid only at the address shown above. Any change in address must be reported to the Chief Firearms Officer 30 days prior to the change.

Cease to Operate: The Chief Firearms Officer must be notified 30 days prior to the business ceasing to

Posting of Licence: The business licence, including conditions, shall be posted in a conspicuous place in the business.

Advertisement: The business must not depict or promote violence.

Business Activities (continued) - Activités de l'entreprise (à suivre)

Over Capacity Magazines: This licence does not authorize the purchasing of any over-capacity magazines or components of over-capacity magazines for conversion.

Other Licences: The business must maintain any business licence or permit issued to it by the province, municipality, township, local government or other organization in relation to operating a business that possesses firearms and/or ammunition. If such licence is suspended, revoked or otherwise no longer valid, the business must advise the Chief Firearms Officer immediately.

Employees: The Chief Firearms Officer must be notified forthwith of any new employee hired by the business who handles or would handle firearms, prohibited weapons or prohibited devices; and, of any such employee who ceases to be employed by the business in that capacity or at all.

Accidents or Injuries: Any intentional or unintentional discharge of a firearm that causes injury to a person or damage to property must be reported to a peace officer and to the Chief Firearms Officer without delay.

Transport: Properly licensed employees of the business are permitted to transport firearms for the purpose of carrying out the activities and prescribed purposes authorized by the licence, including attendance at gun shows. Employees transporting the firearms must be in possession of a copy of the business licence and their personal firearms licence.

Firearms must be transported in accordance with the provisions of the Storage, Display and Transportation of Firearms and Other Weapons by Business Regulations.

This authority is only valid in the province in which it was issued. Transportation in other provinces or territories requires prior authorization of the Chief Firearms Officer of jurisdiction.

Theft or Loss: The business shall immediately inform a peace officer and the Chief Firearms Officer when there is a theft or loss of firearms, weapons, devices or ammunition.

Business Activities (continued) - Activités de l'entreprise (à suivre)

Written Records: Written records must be kept of all transactions involving restricted and prohibited firearms, prohibited weapons or prohibited devices. Transactions include: buying, selling, lending, giving, manufacturing, taking in pawn, gunsmithing, consignment, storage, deactivation, destruction or dismantling of firearms for parts.

Written records for restricted and prohibited firearms must include: make, mode and serial number of the firearm, any inventory number, the registration number, name and firearms licence number of the person for whom the firearm was acquired and the name and firearms licence number of the person to whom the business provided the firearm to, and the date of the transaction.

Registration: On receipt of the registration certificate number for a restricted or prohibited firearm in the business inventory, the business shall ensure that the serial number recorded on the registration certificate corresponds to the serial number inscribed on the firearm. If the numbers do not correspond, the business must contact the Registrar to make the necessary corrections.

All restricted and/or prohibited firearms on the business premises must be registered other than antiques or replicas. With the consent of the Chief Firearms Officer, the business may possess unregistered firearms only in order to verify newly imported unregistered restricted or prohibited firearms for the purpose of registration.

Inspection: For the purpose of business inspections, the business shall produce an inventory as directed by the Chief Firearms Officer of all firearms, weapons, prohibited ammunition, prohibited devices and components used for the assembly of automatic firearms present at the location of the business.

Inventory: The holder of this licence cannot acquire inventory without the approval of the Chief Firearms Officer.
